

# Privacy Policy

## Who We Are

Senior Learners, Inc. (SLI) is a non-profit organization dedicated to providing educational opportunities to seniors (those of us who are at least 50 years old) by presenting noncredit, college-level classes covering a broad range of academic interests.

From time to time we may also provide other activities including luncheons, dinners, picnics, and excursions to promote social interaction among our members.

This page informs you of our policies regarding the collection, use, and disclosure of Personal Information when you use our website (the "Site"). We will not use or share your information with anyone except as described in this Privacy Policy.

## Information Collection and Use

While using our Site, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include but is not limited to, your email address, name, phone number and postal address ("Personal Information"). We use your Personal Information to register you for our courses. We may also provide your personal information to the instructors of the classes you enroll in so they may contact you.

## Retention of Personal Data

Senior Learners will retain your personal data for only as long as needed for the purposes for which the personal data is processed and to meet legal obligations.

## Service Providers

All course registration information is managed through a service provided by Wild Apricot ([wildapricot.com](http://wildapricot.com)) and is governed by their privacy policy (<https://www.wildapricot.com/privacypolicy>). Wild Apricot has access to your Personal Information only to perform these tasks on our behalf and is obligated not to disclose or use it for any other purpose.

## Security

The security of your Personal Information is important to us, but remember that no method of transmission over the internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its

absolute security.

## **Links To Other Sites**

Our Site may contain links to other sites that are not operated by us. If you click on a third-party link, you will be directed to that third party's site. ## **What Rights You Have Over Your Data**

If you have registered for a course using our Site, you can request to receive an exported file of the personal data we hold about you, including any data you have provided to us. You can also request that we erase any personal data we hold about you. This does not include any data we are obliged to keep for administrative, legal, or security purposes.

## **Children's Privacy**

Our Site is not directed to individuals under the age of 16, and we request that individuals under 16 not provide personal data to Senior Learners or Wild Apricot. If we learn that we have collected personal data from a child under 16, we will take steps to delete the information as soon as possible.
